**Authorship policy**

The success of the UK HFpEF registry will depend on contributions from a large number of centres. It is important that those who have made contributions are appropriately acknowledged. Authorship is both expression of responsibility and of achievement. Those whose names appear on a paper should be capable of defending the integrity of the data, the analysis and the conclusion and at least one of them should be responsible for the concept and the conclusion of the work. Following the guidelines of the publishers is vital for our authorship policy to be legally and ethically valid, particularly since all the authors have to be signatories to the affirmation that these guidelines had been adhered to. The policy aims to be inclusive.

- 1. The authorship list is always finished by the statement (on behalf of the UK-HFpEF investigators). All principal investigators at each site will be acknowledged on a separate list (and included in the supplemental material) that will be maintained by the study management team, with an onus on investigators to ensure their details are current. Specific roles including the Executive Steering Committee, the Working Group and the data-monitoring group will be acknowledged (where members of these groups are not cited as authors).
- 2. The authorship should include the person/persons responsible for obtaining the project grant and establishing the UK-HFpEF study data-base (Chair).
- 3. The authorship should include the person/persons responsible for the concept of each of the secondary analyses or sub-studies emanating from the UK-HFpEF study.
- 4. The authorship should include those top recruiting principal investigators to each of the studies or sub-studies. This is in recognition of their contribution to the data and as an incentive for researchers to recruit. For papers emanating from the core dataset, it is envisaged the top 10 sites will be included; for sub-studies this will depend on the number of sites recruiting to the substudy.
- 5. The authorship should include the person/persons responsible for the data management in the study/sub-study who performed the analysis, and other key technical input, if not already included in 2.
- 6. The authorship should include those from the Executive Steering Committee or the wider Working Group making a material contribution to the paper in question.
- 7. The authorship order of each manuscript will be decided by the Pl/author driving the analysis in conjunction with the chair particularly in regards first authorship, last and corresponding authors. The Executive Steering Committee anticipate that multiple out puts will be driven by fellows/analysts who may not be a Pl at a given site but nonetheless could be first author.
- 8. In cases of disagreement, authorship will be decided by the Executive Steering Committee after consideration of contribution statements in line with the IJCME policy with the chair having a casting vote if necessary.
